

# JACKSONIAN 2025 CULINARY COURT September 20, 2025

Welcome to our STREET FAIR for the year 2025! The City of Scottsville is celebrating the Jacksonian Days.

Again, this year, the activities on Saturday, September 20<sup>th</sup> will be on the downtown Scottsville Square.

We have joined with other organizations in the community to make this a fun filled profitable day. Set up begins at 7:00am (CST) and vehicles **MUST** be off the street no later than 9:00am. Arrival and setup **MUST** be completed by 9:00am. Pedestrian safety is a top priority, therefore, if you fail to meet this set up time you will **NOT** be allowed to participate in the event. Vendors will **NOT** be permitted to set up or leave equipment prior to the event set up at 7:00am Saturday morning.

We kindly ask when you arrive to set up that you unload your vehicle and move to one of the public parking lots. This is to ensure everyone gets unloaded and set up in a timely manner. If you need directions, please ask.

You are to assume all responsibility for items and personnel working in the booth and will not hold the City of Scottsville liable for damage to property, theft, personal injury, inclement weather, or other accidents which may occur. There will be **no passenger vehicles** allowed in the food spaces after initial setup, only food wagons & trailers.

**APPROVED VENDOR REGISTRATION FEE IS NON-REFUNDABLE.** Booth assignment will be based on receipt and approval of application and fee and amount of space needed for booth set-up. Electrical hook-up availability is LIMITED; therefore, registrations needing electricity will be on a "first come, first served" basis.

Each booth space is 9' x 22'. Local non-profit organizations (clubs, church groups, scouts, etc.) are \$25 per space. Other food vendors are \$100 per booth space and if additional space outside of the 9" x 22" is required an additional booth space fee of \$125 will be required.

**For public safety we ask that you not begin takedown until the event is over. We will not allow vehicles past the barricades until 3:00pm.**
